Bridge File Management Requirements

- Manual for Bridge Evaluation Section 2
- General File
 - Plan and Elevation or Field Measurements
 - With labeled components to support inspection
 - Location Photos
 - History of any damage
- Field Inspection Information
 - This is covered by standard BrM Inspection input
 - Storage of field inspection in a document form as an inspection report is common

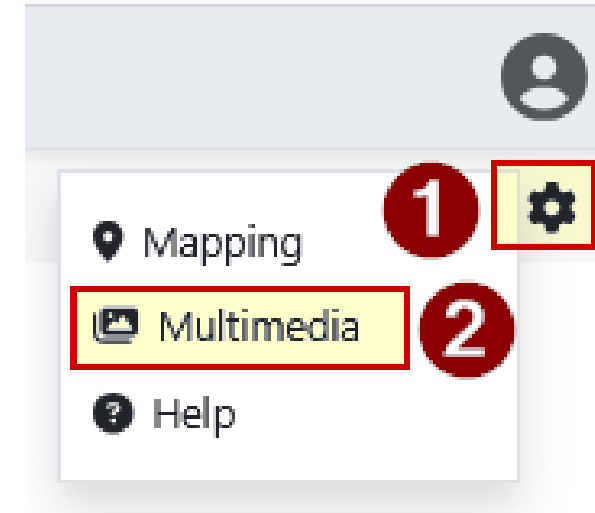
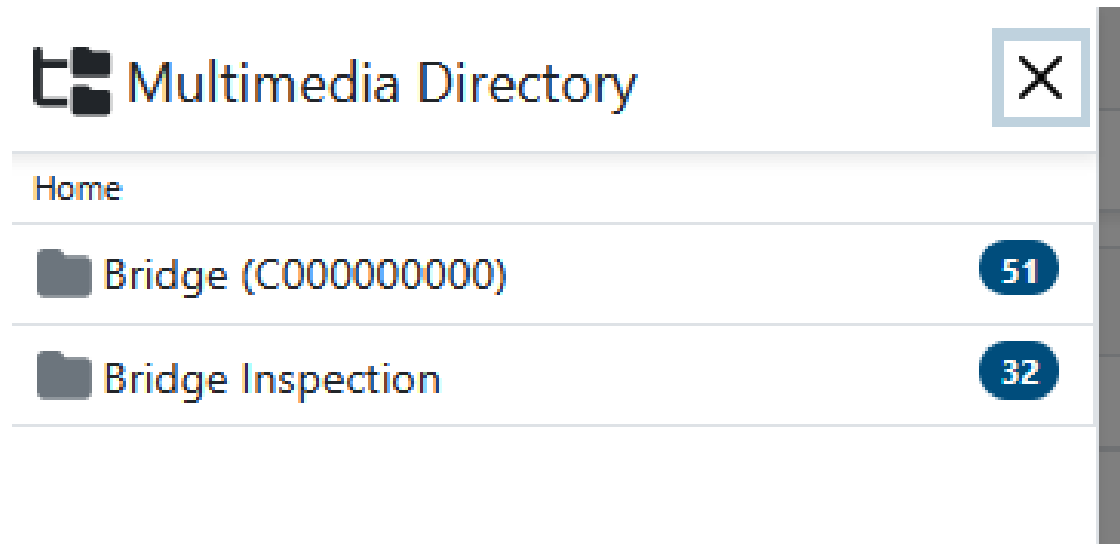
- Critical Findings and Actions Taken
- Waterway information
 - Cross sections
 - Plans of Action
 - Scour Assessment
- “Significant Correspondance”
 - MOUs other agreements
- Inspection Procedure Requirements

Bridge File Management Requirements

- Load Rating Information
 - Certified Load Rating Summary Reports
 - Load rating calc files and models
 - Posting Documentation

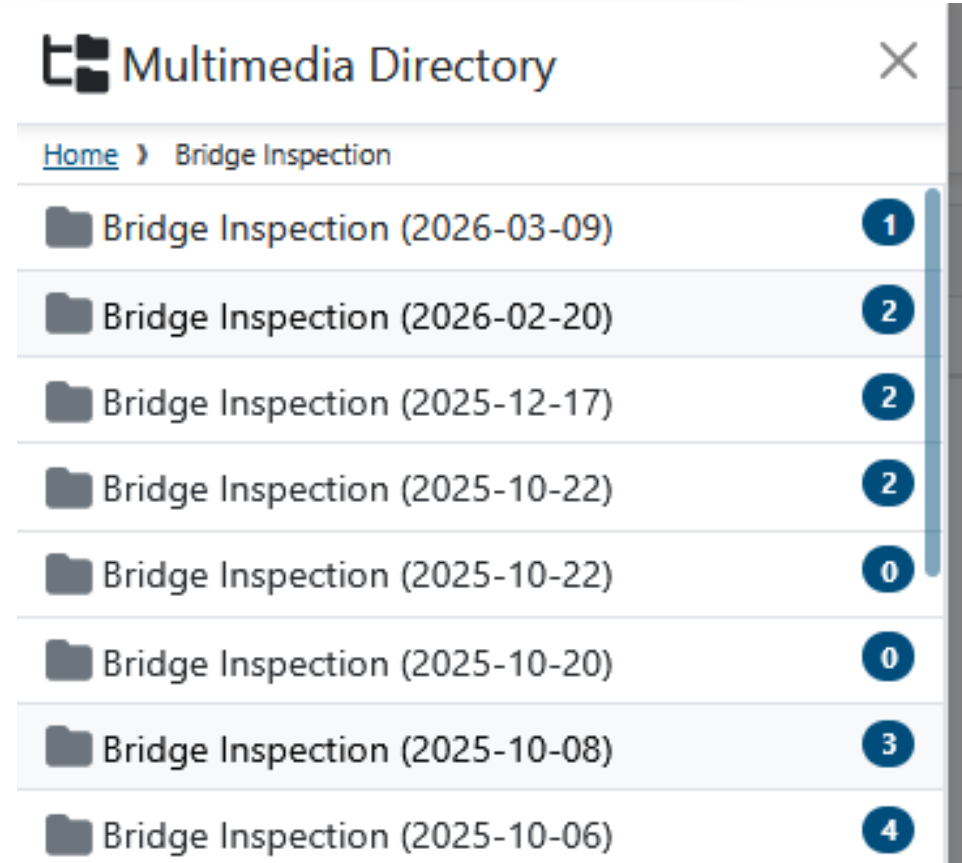
Multimedia for Bridge File Management

 - NDOT uses these for inspection photos only

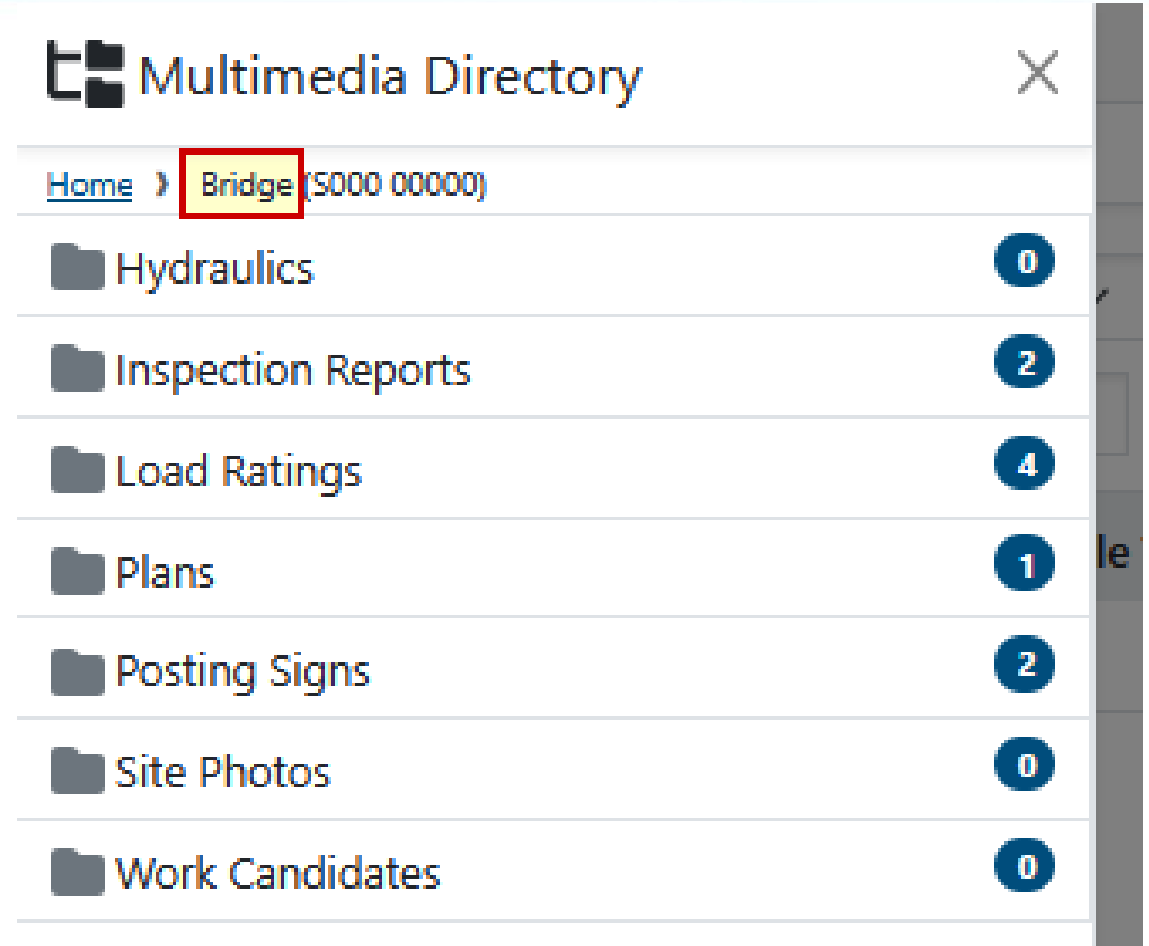
