

Mayvue is currently developing the enhancements and will provide to the beta testing TAG in the near term for testing. Stay tuned for multimedia enhancements in the 6.4 release.

BrM 6.3 – Current Available Release

Released February 2020

Key Features

- Inspection Scheduler to assign and manage upcoming inspections
- Component Level Deterioration to evaluate multiple deterioration profiles for each component of a bridge
- Scheduled Processes to run certain BrM services at regularly scheduled intervals

AASHIO

 Tunnel Work Candidates to capture maintenance needs for tunnels

Bridge Management 6.4 Release

- Anticipated Release at end of 2020
- Multimedia module enhancements:
 - Widget to more easily access multimedia files from within specific tasks
 - Better organization of UI as well as new fields and features
 - A foundation for integrating BrM multimedia with other multimedia platforms (e.g. ProjectWise)
- Addition of the remaining FHWA validation checks



Bridge Management 6.4 Release

- Addition of "Date Entered" and "Entered By" fields on the Tunnel Inspection page
- Integration of approved service unit customizations into core including policy rule weighted element condition states and the availability of an improved Optimizer log
- Usability enhancements and various maintenance improvements / bug fixes



Lifecyle Cost Analysis (LCCA)

Future Release (TBD)

- Scope includes enhancements to the LCCA module that will assist agencies in creating life-cycle plans that incorporate bridge profiles as part of a network analysis
- Technical Advisory Group involvement on the front end
- Outcome: More refined Life-Cycle Cost Analysis to allow agencies to create bridge level life-cycle plans that fit their specific practices and policies for any bridge
 - Agencies will be able to easily program work in the short term (5 years or less) or develop a long-term program (10, 15, 20, 50 years, etc.)

AASHIO

LCCA policies can be used to prevent the bridge from falling below a certain threshold

Bridge Management 7.0 – Looking Ahead

- Task Force Primary Focus is on changes required to stay compliant with new NBIS Regulations and the new NBI coding guide
- Currently developing plan for proposed changes to ensure timely delivery of BrM 7.0 to allow states time to implement ahead of FHWA deadlines



Bridge Management 7.0 – Looking Ahead

- Solicitation to support compliance with the proposed changes to the NBIS and the new NBI coding guide
 - One time cost
 - Part of AASHTO model to keep license fee costeffective and economical
 - Ensure modeling component will continue to operate and adapt to historic data and new data in required format
 - Leverage opportunity of improving asset management process while adapting to new proposed data sets



Bridge Management 7.0 – Looking Ahead

- BrM 7.0 to also include deferred maintenance items and usability enhancements
 - Deferred database maintenance
 - Merge bridge into cross asset
 - Multi-thread optimization process
 - Tracking historical changes on a granular level
 - Workflow improvements
 - Dashboards
